



### CiberLaw Maintenance and Support Agreement

Amendment #3 to  
CiberLaw Maintenance and Support Agreement and Statement of Work  
Between  
HTC Global Services (successor by merger to Ciber Global, LLC)  
And  
Dakota County Attorney

This document (“**Amendment Number 3**”) dated June 6, 2026, shall serve to amend the CiberLaw Maintenance and Support Agreement (the “**Agreement**”), as previously amended, and the Statement of Work (“**SOW**”) with effective date of November 1, 2015, incorporated therein, all between HTC Global Services, Inc., successor by merger to Ciber Global LLC, (“**Contractor**”) and Dakota County Attorney (“**Customer**”).

NOW THEREFORE, Customer and Contractor, by entering into this Amendment Number 3, mutually agree that effective November 1, 2026, the following provisions shall modify the Agreement.

Term: The Term of the Agreement is hereby extended by and through December 31, 2031.

The SOW is hereby amended as follows.

**Section 2.3 (Roles)** is hereby amended to delete the 50% shared resource model between Anoka County and Dakota Counties. Dakota County developer resource allocation will now be 100%.

Roles across the agreement are now modified to combine the .Net Developer and QA roles into a single Developer Role due to the maturity of the solution. All references to a separate QA Role are no longer warranted.

**Section 2/Table 1 (Consultant Roles)** is hereby modified to:

**Section 9. (Early Termination), paragraph 2** is hereby deleted in its entirety and replaced with the following:



By Customer: Notwithstanding any other provision of the Agreement or this SOW, in the event that Customer seeks to terminate this SOW for convenience, it may only do so upon ninety (90) days written notice to Contractor.

**Section 10. (Commencement Date and Term), paragraph 2, sentence 2** is hereby amended to extend the term of the SOW to December 31, 2031.

All other terms and conditions of the SOW effective November 1, 2015, shall remain unchanged and in full force and effect.
