Public Hearing To Receive Comments On Proposed Ordinance Regulating Registration And Sale Of Cannabis Products In Dakota County, Adopt

Ordinance, And Amend 2025 Fee Schedule

Motion: Joe Atkins Second: William Droste

The time being 9:07 a.m., and pursuant to public notice, a public hearing was

conducted for the purpose of receiving comments on the proposed ordinance regulating registration and sale of cannabis products in Dakota County. Public Services and Revenue Deputy Director Teresa Mitchell briefed this item and the public hearing was opened. No one came forward for comment. The public hearing was closed at 9:08 a.m.

WHEREAS, the purpose of this ordinance is to implement the provisions of Minnesota Statutes, Chapter 342, which authorizes the retail registration and sale of cannabis and lower-potency hemp products, and to protect the public health, safety, and welfare of Dakota County residents by regulating retail cannabis and hemp businesses within the legal boundaries of Dakota County where the city or township consents to Dakota County administering registration of retail cannabis businesses and lower-potency hemp businesses from Dakota County; and

WHEREAS, pursuant to the authority vested in it by Minn. Stat. § 342.13 to adopt reasonable restrictions of the operation of a cannabis business in any political subdivision located in Dakota County that has consented to Dakota County to regulate the registration and sale of cannabis products; and

WHEREAS, pursuant to the authority vested in it by Minn. Stat. § 342.22 to issue local registrations to retailers for the sale of cannabis and lower-potency hemp products in any political subdivision located in Dakota County that has consented to Dakota County to regulate the registration and sale of cannabis products and lower-potency hemp products; and

WHEREAS, by Resolution No. 25-215 (April 22, 2025), the County Board of Commissioners scheduled the public hearing and directed the publication of the intent to adopt a cannabis ordinance; and

WHEREAS, the Notice of Public Hearing was published in the County's Official Newspaper on May 8 and 15, 2025, and was posted to the Dakota County website; and

WHEREAS, dialog with a local business representative brought to light a necessary amendment to the draft ordinance removing the restriction during stated holidays that proposed to align with Ordinance No. 101 Regulating the Licensing and Sale of Intoxicating Liquor; and

WHEREAS, the amendment to the published ordinance reflects the limitations under State laws for imposing a time restriction for cannabis and low-potency hemp sales during public holidays; and

WHEREAS, to provide for a swift response to any immediate threat to the health or safety of the public as provided in statute, it is necessary to delegate the authority to suspend a retail registration to the Director of Public Services and Revenue Division; and

WHEREAS, staff from the Sheriff's Office, Public Health, and Public Services and Revenue Division recommend that the amended cannabis ordinance is adopted; and

WHEREAS, the 2025 Fee Schedule must be amended to include fees associated under this ordinance for retail registration of cannabis retailers, temporary cannabis event licenses, and penalties for violations of the ordinance; and

WHEREAS, a public hearing is required for the purpose of receiving comments and informing the public of the proposed ordinance Regulating the Registration and Sale of Cannabis Products in Dakota County; and

WHEREAS, a public hearing is required for the purpose of receiving comments and informing the public of the amendment to the 2025 fee schedule in Dakota County.

NOW, THEREFORE, BE IT RESOLVED, That the Dakota County Board of Commissioners held a public hearing at 9:00 a.m. on May 20, 2025, in the Boardroom of the Dakota County Administration Center, 1590 Highway 55, Hastings, Minnesota for the purpose of receiving comments on the proposed Cannabis Ordinance and amendment to the 2025 Fee Schedule in Dakota County; and

BE IT FURTHER RESOLVED, That the Dakota County Board of Commissioners hereby adopts the Cannabis Ordinance, Regulating the Registration and Sale of Cannabis Products as presented on May 20, 2025; and

BE IT FURTHER RESOLVED, That the Dakota County Board of Commissioners sets the registration fee for a Cannabis Retailer at \$500 for the initial registration, and \$1,000 for the second and each subsequent registration renewal; and

BE IT FURTHER RESOLVED, That the Dakota County Board of Commissioners sets the registration fee for a Lower-Potency Hemp Retailer at \$125 for the initial registration, and \$125 for the second and each subsequent registration renewal; and

BE IT FURTHER RESOLVED, That the Dakota County Board of Commissioners sets the registration fee for a Medical Combination Retailer at \$500 for the initial registration, and \$1,000 for the second and each subsequent registration renewal; and

BE IT FURTHER RESOLVED, That the Dakota County Board of Commissioners sets the registration fee for a Mezzobusiness Retailer at \$500 for the initial registration, and \$1,000 for the second and each subsequent registration renewal; and

BE IT FURTHER RESOLVED, That the Dakota County Board of Commissioners sets the registration fee for a Microbusiness Retailer at \$0 for the initial registration, and \$1,000 for the second and each subsequent registration renewal; and

BE IT FURTHER RESOLVED, That the Dakota County Board of Commissioners sets the registration fee for a Temporary Cannabis Event License at \$150 for a 1-2 day event; and

BE IT FURTHER RESOLVED, That staff shall publish, distribute, and file the amended ordinance pursuant to Minn. Stat. § 375.51.

Proclamation Of May As Mental Health Month

Motion: Mary Hamann-Roland Second: Laurie Halverson

WHEREAS, May is National Mental Health Month; and

WHEREAS, according to the National Alliance on Mental Illness and the Center for Disease Control:

- One in five United States (U.S.) adults experience mental illness
- One in twenty U.S. adults experience serious mental illness
- 50 percent of all lifetime mental illness begins by age 14, and 75 percent by age 24
- In 2024, 1 in 5 employees in the U.S. reported experiencing burnout, with mental health problems being one of the key contributors. (nami.org)
- 1 in 5 children aged 3-17 in the U.S. have a mental health condition, with ADHD, anxiety, and depression being the most common diagnoses

; and

WHEREAS, mental health is an important determinant of overall health and well-being for individuals; and

WHEREAS, the COVID-19 pandemic, along with compounding community trauma, continues to have a significant impact on adult and child mental health, particularly for people with pre-existing mental illness and Substance Use Disorder (SUD), and for communities of color; and

WHEREAS, many residents are struggling with the long-term impacts of illness, loss of loved ones, social isolation, job loss, changes in routines, racism or other forms of discrimination, and community trauma, resulting in many who are experiencing unprecedented levels of fear, anxiety, and stress; and

WHEREAS, Dakota County has maintained a focus on connecting people to community mental health and SUD services, promoting mental health messaging and initiatives, addressing service needs and gaps through community partnerships, training, and engaging the perspective and voice of people with lived experience; and

WHEREAS, this includes providing community members with practical tools they can use to improve their mental health and increase resiliency; and

WHEREAS, prevention is an effective strategy to reduce the impact of mental health conditions and, with effective treatment, those individuals with mental health conditions can recover and lead full, productive lives; and

WHEREAS, Dakota County has a network of mental health services and initiatives that provide mental health support and promote mental health awareness and education; and

WHEREAS, Dakota County staff, in partnership with other organizations, are committed to building public awareness and addressing stigma as important steps in supporting people to access treatment and support; and

WHEREAS, promoting mental health and awareness of resources and support is especially important given the impacts of the pandemic and community trauma on mental health and well-being; and

WHEREAS, staff recommends that the Dakota County Board of Commissioners proclaim May as Mental Health Month in Dakota County.

NOW, THEREFORE, BE IT RESOLVED, That the Dakota County Board of Commissioners hereby proclaims May 2025 as Mental Health Month in Dakota County and supports efforts to promote mental health awareness, training, education, and access to information, services, and supports to serve the mental health needs of the citizens of Dakota County.

WHEREAS, by Resolution No. 23-444 (September 26, 2023), the 2024 -2028 Parks Capital Improvement Program (CIP) Adopted Budget includes a project to design and construct site developments making Miesville Ravine Park Reserve (MRPR) a better place to serve the adjacent communities; and

WHEREAS, by Resolution No. 24-091 (February 27, 2024), the Dakota County Board of Commissioners authorized the MRPR Master Plan, which outlines the site improvement plans; and

WHEREAS, by Resolution No. 24-545 (November 12, 2024), the Board approved to select HKGi to provide professional design services; and

WHEREAS, since December 2024, staff has worked with a design team led by HKGi to progress the design and related review process; and

WHEREAS, staff reviewed the initial concept with tribal partners virtually on February 6, 2025; and

WHEREAS, a public open house was held in person on February 6, 2025, and project materials were published online for public comments; and

WHEREAS, a public and private stakeholder workshop was held in person on February 7, 2025; and

WHEREAS, due to the complicated physical site conditions and the extensive permitting process, an additional service fee of \$98,650 is required.

NOW, THEREFORE, BE IT RESOLVED, That the Dakota County Board of Commissioners hereby authorizes a contract amendment to increase the contract with HKGi by \$98,650 to a total \$272,595, subject to approval by the County Attorney's Office as to form.

WHEREAS, the County intends to install fiber strands in certain segments within the City of Rosemount as described in this Agreement and Dakota County desires to use existing city-owned conduit for the fiber strands in order to save substantial construction costs; and

Authorization To Execute Joint Powers Agreement With School Districts For Interagency Early Intervention Services

WHEREAS, Dakota County Social Services - Children and Family Services and Dakota County Public Health partner with Dakota County school districts to provide interagency early intervention services to young children with, or at risk of developing, developmental delays; and

Second: Laurie Halverson

WHEREAS, the Minnesota Department of Education allocates federal Individuals with Disabilities Education Act (IDEA) Part C funding to each school district based on the number of children identified for early intervention services; and

WHEREAS, Independent School Districts 191, 192, 194, 195, 196, 197, 199, 200, and Special School District 6 jointly have indicated their intent to continue using these funds to purchase services from Dakota County for early identification of developmental delays via Part C Mini Grants, services, and interagency service coordination; and

WHEREAS, Social Services - Children and Family Services administers the Part C Mini Grant Program and coordinates regular meetings of the Interagency Early Intervention Collaborative; and

WHEREAS, Public Health provides home visits supported through the IDEA Part C allocation through their Maternal and Child Health (MCH) program; and

WHEREAS, this allocation supplements the MCH program grant funds and revenue generated from health insurance and Medical Assistance for home visiting; and

WHEREAS, Dakota County is estimated to receive a total of \$213,190.76 from the noted districts for services provided during the term of the JPA as follows:

- Independent School District 191: \$16,069.65 x 2 = \$32,139.30
- Independent School District 192: \$9,820.34 x 2 = \$19,640.68

- Independent School District 194: \$15,712.55 x 2 = \$31,425.10
- Independent School District 195: \$357.11 x 2 = \$714.22
- Independent School District 196: \$32,139.30 x 2 = \$64,278.60
- Independent School District 197: \$11,962.97 x 2 = \$23,925.94
- Independent School District 199: \$5,713.66 x 2 = \$11,427.32
- Independent School District 200: \$6,784.97 x 2 = \$13,569.94
- Special School District 6: \$8,034.83 x 2 = \$16,069.66

; and

WHEREAS, the total received over the two-year timeframe will be allocated as follows:

- Dakota County Public Health: \$63,381.26 x 2 = \$126,762.52
- Dakota County Social Services: \$21,895.34 x 2 = \$43,790.68
- Part C Mini Grants: \$20,742.95 x 2 = \$41,485.90
- Printing: \$575.83 x 2 = \$1,151.66

; and

WHEREAS, let it be noted that the amounts shown above are estimated amounts based on previous dollars awarded, and amounts listed above can be increased up to 10 percent without Dakota County Board approval.

PURPOSE/ACTION REQUESTED

Approve Dakota County's continued participation in the State of Minnesota's voluntary State Standard Measures Program and report results of ten specific performance measures to the State Auditor by July 1, 2025, and on the County's public website.

SUMMARY

By Resolution No. 11-318 (June 21, 2011), Dakota County opted to participate in the State's voluntary measurement program by adopting ten performance measures. From 2012 to 2024 performance on the ten measures was reported to the State Auditor and to the public via the County website.

As a result of this participation and reporting, Dakota County has received \$25,000 each year from 2012 to 2024. A county or city that elects to participate in the standard measures program for 2025 is eligible for a reimbursement payable in 2026 of \$0.14 per capita in State aid, not to exceed \$25,000. Revenue received will be budgeted under the Office of Performance and Analysis to support ongoing Countywide capacity building and training related to measurement and process improvement.

In order to continue to receive the per capita reimbursement, the County must file a report with the Office of the State Auditor by July 1, 2025, to include a resolution declaring that:

- The County has adopted and implemented the minimum ten performance measures developed by the Council on Local Results and Innovation.
- The County has implemented or is in the process of implementing a local performance measurement system as developed by the Council on Local Results and Innovation.
- The County has or will report the results of the ten adopted measures to its residents through publication, direct mailing, posting on the entity's website, or through a public hearing at which the budget and levy will be discussed and public input allowed. Dakota County each year posts the information on the website.

Many of the ten State program measures (Attachment) are already being tracked or reported on by Dakota County departments or divisions, and so there is minimal additional burden to meet the reporting requirements.

BACKGROUND

In 2010, the State Legislature created the Council on Local Results and Innovation to develop standard performance measures for Minnesota cities and counties. In February 2011, the Council released a standard set of performance measures to help residents, taxpayers, and elected officials determine whether counties provide services efficiently and effectively, and to measure residents' opinions of those services. In 2011, Dakota County voluntarily agreed to participate in the program. To meet 2025 program requirements, the following results are reported for the 10 adopted measures using the most recent data available.

PUBLIC SAFETY

Group A and B Crime Rate

There are two categories of crime reported within the National Incident-Based Reporting System (NIBRS): Group A and Group B.

Group A crimes include murder, rape, aggravated assault, burglary, larceny, motor vehicle theft, arson, human trafficking, counterfeiting/forgery, embezzlement, sex offenses, stolen property, prostitution, gambling, vandalism, weapons, and narcotics.

Examples of Group B crimes include bad checks, curfew/loitering/vagrancy violations, disorderly conduct, driving under the influence, drunkenness, nonviolent family offenses, liquor law violations, peeping tom, trespass of real property, and all other offenses.

Supervision is provided randomly throughout the week including evenings, nights, weekends, and holidays. Client interactions occur in the client's residence, place of employment, or treatment programs.

Community Corrections has applied for and received grant funding to provide ISR services in Dakota County since 1995. Community Corrections currently has three full-time ISR Officers who work with clients identified as very high-risk.

In April 2025, Community Corrections applied for grant dollars in an amount not to exceed \$74,850 for the grant period of July 1, 2025 through December 31, 2025. Staff recommends a modified grant agreement accepting funds of \$74,850 for 6 months ending December 31, 2025.

On January 1, 2026, ISR clients living in Dakota County will be supervised by the DOC, and no longer under supervision by Dakota County. When ISR is returned to the DOC, they will provide all services required by state statute that are currently provided by Dakota County.

PURPOSE/ACTION REQUESTED

Authorize execution of a contract amendment with Hoisington Koegler Group Inc. (HKGI) to provide permitting and stormwater modeling tasks and construction administration services related to the pollinator promenade and daylit stream on the Thompson County Park Phase II Master Plan Improvements project.

SUMMARY

The Thompson County Park Master Plan was approved by the Dakota County Board by Resolution No. 20-037 (January 21, 2020).

HKGI was issued a contract to provide programming and schematic design services by Resolution No. 23-484 (October 24, 2023). These included a range of eight items suggested in the Master Plan, and the contract sum was \$476,426. HKGI's contract was then amended by Resolution No. 24-089 (February 27, 2024) to provide continued design services, which included design development and construction documents specifically for the pollinator promenade and daylit stream elements of the Master Plan in the sum of \$113,989. A second contract amendment has been issued for a time extension only.

This amendment will provide permitting assistance, stormwater modeling tasks, bidding, and construction administration services for the pollinator promenade and daylit stream in the sum of \$84,000. The proposal for additional service request is included in Attachment, Fee Proposal.

RECOMMENDATION

Staff recommends authorizing an amendment with HKGI to provide permitting assistance, stormwater modeling tasks, bidding, and construction administration services on the Thompson County Park Phase II Master Plan Improvements project in an amount not to exceed \$84,000. The total authorized contract amendments to this contract would then total \$197,989.

EXPLANATION OF FISCAL/FTE IMPACTS

The County has received \$2,000,000 from the State for design services related to Thompson County Park. This budget is sufficient to cover all costs of the design and construction administration contract.

Authorize execution of construction and maintenance and right of entry agreements with Canadian Pacific Kansas City (CPKC) Railway Company for the construction of a new bicycle and pedestrian bridge over CPKC right of way and Robert Street (Trunk Highway 3) for the Veterans Memorial Greenway (P00147), located between Diffley Road and Cliff Road near Tofte Lane in the cities of Inver Grove Heights and Eagan.

SUMMARY

Dakota County is proceeding with construction of the Veterans Memorial Greenway (P00147), a planned regional trail connection between Lebanon Hills Regional Park and the Mississippi River Greenway. A central feature of this project is a new pedestrian and bicycle bridge crossing over the CPKC Railway and Robert Street (Trunk Highway 3), located between Diffley Road and Cliff Road near Tofte Lane. This bridge is essential to providing a continuous and safe greenway alignment.

To facilitate this project, Dakota County has coordinated with CPKC to secure the necessary legal agreements, which outline the County's rights and obligations:

Construction and Maintenance Agreement

- This agreement authorizes Dakota County to construct, maintain, and operate the pedestrian bridge and associated infrastructure within CPKC's right of way.
- Dakota County is responsible for all design, construction, and maintenance costs associated with the bridge, as well as any modifications or repairs required to meet safety or operational standards.
- CPKC retains the right to inspect the project site during construction to ensure compliance with railroad safety standards.
- The County is required to follow CPKC's specified protocols for construction, including flagging services and track protection measures during work periods.
- Ongoing maintenance responsibilities for the bridge and any associated infrastructure rest with Dakota County, including inspections and any necessary repairs.

Right of Entry Agreement

 This agreement grants Dakota County temporary access to CPKC property for construction activities.

- It establishes a \$1,500 execution fee and outlines requirements for railroad protective services, such as flagging, which are estimated not to exceed \$75,000.
- The agreement specifies strict safety protocols, including compliance with CPKC's "Minimum Safety Requirements for Contractors Working on CPKC Property," which mandates protective equipment, flagging operations, and e-railsafe certification for all personnel entering the site.
- CPKC retains the right to monitor construction activities and require adjustments to work practices if they conflict with rail operations or safety requirements.

Execution of these agreements is necessary to proceed with bid advertisement and maintain the current construction timeline.

RECOMMENDATION

Staff recommends execution of agreements with Canadian Pacific Kansas City to authorize construction of the greenway bridge and temporary construction crossings over CPKC track.

EXPLANATION OF FISCAL/FTE IMPACTS

The Right of Entry Agreement includes a \$1,500 execution fee. Additional costs related to flagging, inspection, or protective services required by CPKC will be billed directly to the County and are anticipated to total less than \$75,000. Successful completion of this project relies upon a \$5,995,000 Federal Congressionally Directed Spending allocation and \$10,000,000 in State appropriated funds. Sufficient funding is available for the agreements and associated fees in this request.



PURPOSE/ACTION REQUESTED

Authorize the execution of a joint powers agreement (JPA) with the City of Burnsville to establish roles, responsibilities, and cost share for the incorporation of City of Burnsville utility improvements as part of the County's 2025 preservation activity occurring on County State Aid Highway 30 (Diffley Road) from Trunk Highway 13 to Interstate Highway 35E, County Project (CP) 30-43.

SUMMARY

To provide a safe and efficient transportation system, Dakota County is proceeding with the 2025 preservation of paved highway surface and miscellaneous projects. The 2025 preservation work includes pavement mill and overlay of County roadways, replacement of pedestrian curb ramps at intersections to meet the requirements of the Americans with Disabilities Act, application of pavement markings, and necessary repairs to city utilities. As part of the County's preservation process, coordination occurs with the city partners to determine if any utility improvements are necessary on the segments of roadways being improved that would be advantageous to include with the preservation work. Incorporating these improvements saves the stakeholders time and money and also reduces the burden on the traveling public as the traffic impacts are consolidated into one project versus multiple. These improvements often include repairs to the storm sewer, sanitary sewer, or water main facilities.

Coordination with the City of Burnsville resulted in their desire to include utility improvements with the bid packages for CP 30-43. In order to facilitate these improvements with the County's 2025 preservation activity, a JPA is necessary to establish the roles, responsibilities, and cost share for the work. The City of Burnsville is responsible for 100 percent of the costs associated with any water main or sanitary sewer work. For storm sewer work, the cost share is 80 percent County and 20 percent City in accordance with the terms and conditions of the current adopted Maintenance Agreement for Storm Sewer Systems (Dakota County Contract No. C0025409).

By resolution 25-078 (February 2, 2025), the board authorized the execution of a JPA with the City of Burnsville for CP 11-32 which is also included in the County's 2025 Preservation Projects. At the time of the board action, County staff was not aware of Burnsville's desire to include additional utility improvements with CP 30-43. The intention is to execute a single JPA with the City of Burnsville that covers the roles, responsibilities, and cost share for both CP 11-32 and CP 30-43.



The existing trail gap is noted in the 2018 Dakota County Pedestrian and Bicycle Study as a high priority for future improvements.

Design of the project was completed in January 2025, and the County advertised for bids for construction on April 25, 2025, with bids due on May 20, 2025. Five bids were received by the May 20, 2025, deadline:



Design documents were prepared by the KLJ Engineering LLC team in consultation with staff. Dakota County advertised a Request for Bids on March 17, 2025. On April 15, 2025, five qualified bids were received as follows:

Staff has reviewed the bids and determined that Thomas & Sons Construction, Inc., has submitted the lowest responsive and responsible bid of \$1,968,228.43. The lowest bid is approximately 19.9 percent lower than the engineer's estimate of \$2,458,616.70 for CP 28-76.

An amendment is requested to the 2025 CIP Adopted Budget to increase construction budgets for CP 28-76. The City's overall cost share decreased due to competitive bid pricing for the traffic signal

for which the City has a 50 percent cost share. The budget amendment requested also includes funds of \$64,771.57 to cover additional construction services. The County's budgeted cost share has increased by \$675,000 due to added micro-surfacing and an increase in construction costs.



Board action is required as the value of total amendments after initial authorization of the contract execution exceeds a policy limit of \$50,000.

SUMMARY

The LEC IHU Addition project was first considered nearly three years ago, and construction is now complete. The design contract was awarded to Wold Architects and Engineers in the sum of \$675,000 by Resolution No. 22-257 (June 21, 2022). The schematic design for the project was presented by Resolution No. 22-480 (November 15, 2022), and the scope of the project had then increased sufficiently that near the end of design, Wold requested an amendment to their contract to account for such changes. An amendment to the design contract with Wold Architects and Engineers in the sum of \$135,000 was authorized by Resolution No. 23-264 (June 20, 2023). That brought Wold's contract total to \$810,000, which included \$24,000 in estimated reimbursable expenses.

In this action, staff is requesting a second contract amendment with Wold Architects and Engineers in the sum of \$8,488.49 for reimbursable plan review costs that exceeded the earlier estimated amounts. Plan reviews by the State of Minnesota, the Department of Corrections, and the City of Hastings were all required for the project. These fees were \$32,488.49 and exceeded the estimated \$24,000. Wold is therefore asking for an amendment to their contract of \$8,488.49 to account for the increase. This increase to the design contract will be paid for with reserved funds remaining within the original project budget.

RECOMMENDATION

A \$135,000.00 contract amendment has already been authorized by Resolution No. 23-264 (June 20, 2023). Staff recommends authorizing a second contract amendment with Wold Architects and Engineers in the sum of \$8,488.49 for plan review fees incurred at the LEC IHU. This brings the total authorized contract amendments to this contract to \$143,488.49 and the new contract value to \$818,488.49.

Authorization To Execute Lease Agreement Between Dakota County And Minnesota State Board Of Public Defense For Office Space Located At Judicial Center In Hastings

PURPOSE/ACTION REQUESTED

Authorize execution of the lease agreement with the Minnesota State Board of Public Defense for approximately 535 rentable square feet of office space located in the Dakota County Judicial Center in Hastings.

SUMMARY

Dakota County has been leasing space in the Judicial Center to the Minnesota State Board of Public Defense. The current lease agreement expires June 30, 2025, and has a rate of \$24.42 per square foot annually.

Staff and representatives from the State Board of Public Defense have agreed to the rental rates listed below:

July 1, 2025, through June 30, 2026: \$24.79 per square foot annually July 1, 2026, through June 30, 2027: \$25.16 per square foot annually

The rates are consistent with comparable County space.

The one-year lease term will extend automatically unless the State Board of Public Defense provides written notice not to extend. In the event the County needs the space occupied by the State Board of Public Defense, the County can terminate the lease by providing a 30-day notice.

The new rental rates will provide adequate reimbursement for anticipated increases in County operating costs. The lease will be extendable on an annual basis for up to one year, through June 20, 2027, consistent with the State Board of Public Defense funding cycle.

RECOMMENDATION

Staff recommends that the County Board authorize execution of the lease agreement with the Minnesota State Board of Public Defense for office space located in the Dakota County Judicial Center in Hastings, Minnesota.

LEASE AGREEMENT

THIS LEASE AGREEMENT is made by and between the County of Dakota, a political subdivision of the State of Minnesota, by and through its Facilities Management Department, 1590 Highway 55, Hastings, Minnesota 55033, hereinafter referred to as "LESSOR," and the State Board of Public Defense, 331 Second Avenue S., Minnesota, 55401, hereinafter referred to as "LESSEE," acting on behalf of the First Judicial District Public Defender.

WITNESSETH: The LESSOR and the LESSEE, in consideration of the rents, covenants and consideration hereinafter specified, do hereby agree each with the other as follows:

- 1. The LESSOR grants and the LESSEE accepts a Lease Agreement, commencing July 1, 2025, of the following described premises located in the City of Hastings, County of Dakota, Minnesota, to wit:
 - 1.1. Year One: From July 1, 2025 through June 30, 2026; Approximately five hundred thirty-five (535) usable square feet of the office space on the lower and main levels of the Dakota County Judicial Center located at 1560 Highway 55, Hastings, Minnesota.
 - 1.2. Year Two: From July 1, 2026 through June 30, 2027; Approximately five hundred thirty-five (535) usable square feet of the office space on the lower and main levels of the Dakota County Judicial Center located at 1560 Highway 55, Hastings, Minnesota.
- 2. LESSOR represents and warrants that it is solely entitled to all rents payable under the terms of this Lease Agreement and that LESSEE shall have the quiet enjoyment of the leased premises during the full term of this Lease Agreement and any extension thereof, according to the terms of this Lease Agreement.

3. TERM:

3.1 The initial term of this Lease Agreement shall be from July 1, 2025, to June 30, 2026 as set forth in Section 1.1. of this Lease Agreement. If this Lease Agreement is not terminated during the initial term set forth in Section 1.1 of this Lease Agreement, then the Lease Agreement shall automatically extend as set forth in Section 1.2. of this Lease Agreement. All provisions of this Lease Agreement shall remain in force and effect after the Lease Agreement is automatically extended, with no option to negotiate or renegotiate any new or existing terms or conditions. This extension merely continues the original Lease Agreement. Unless otherwise agreed to by the parties in a separate writing, the Lease Agreement shall terminate after the term set forth in Section 1.2. of this Lease Agreement.

4. TERMINATION:

This Lease Agreement may be terminated by either party by giving the other party 30-day written notice of intention to terminate on or before May 1, 2026. Such written notice of intention to terminate shall state the reason for termination. If the LESSOR terminates this Lease Agreement because it desires all or part of the leased space for other purposes, LESSOR will make every reasonable effort to accommodate LESSEE in comparable space within the Dakota County Judicial Center.

5. RENT:

As rent for the above-described premises, and in consideration of all the covenants, representations and conditions of this Lease Agreement and according to its terms thereof, LESSEE agrees to pay to LESSOR rent at the following rates:

- 5.1. For the period July 1, 2025, through June 30, 2026, the sum of (Thirteen Thousand Two Hundred Sixty-One) and 37/100 Dollars (\$13,261.37), payable in monthly installments of (One Thousand One Hundred Five) and 11/100 Dollars (\$1,105.11) on or before the first day of each month. Annual rent for the period of July 1, 2025 through June 30, 2026 is based on \$24.79/square foot.
- 5.2. For the period July 1, 2026, through June 30, 2027, the sum of (Thirteen Thousand Four Hundred Sixty) and 29/100 Dollars (\$13,460.29), payable in monthly installments of (One Thousand One Hundred Twenty-One) and 69/100 Dollars (\$1,121.69) on or before the first day of each month. Annual rent for the period of July 1, 2026 through June 30, 2027 is based on \$25.16/square foot.
- 6. LESSEE covenants that at the termination of this Lease Agreement by lapse of time or otherwise, it shall remove its personal property and vacate and surrender possession of the leased premises to LESSOR in as good condition as when LESSEE took possession, ordinary wear and damage by the elements excepted. The premise shall be considered vacated only after all areas including storage areas are clear of LESSEE's belongings, and keys and other property furnished for LESSEE are returned to LESSOR. Alterations or fixtures attached to the leased premises shall remain a part thereof and shall not be removed unless LESSOR elects to permit removal.
- 7. If the premises are destroyed or damaged by fire, tornado, flood, civil disorder, or any similar cause whatsoever, so that the premises become untenantable, the rent shall be abated from the time of such damage and the LESSEE shall have the option of terminating this Lease Agreement immediately or allowing the LESSOR such amount of time as the LESSEE deems reasonable to restore the damaged premises to tenantable condition.
- 8. In the event that the Minnesota State Legislature does not appropriate to the Minnesota State Board of Public Defense funds necessary for the continuation of this Lease Agreement, or in the event the Federal Funds necessary for the continuation of this Lease Agreement are withheld for any reason, this Lease Agreement may be terminated by the LESSEE upon giving thirty (30) days written notice.
- 9. LESSOR shall be responsible for all assessments upon the leased premises.

10. DUTIES OF THE LESSOR:

- 10.1. LESSOR shall provide adequate electrical outlets upon the leased premises for normal office use.
- 10.2. LESSOR shall provide the leased premises with access to restroom facilities for both men and women. Such facilities shall be located with the building common areas accessible to the leased space.

- 10.3. Heating: LESSOR shall provide the leased premises with heating facilities of a design capacity sufficient to maintain the leased premises at a comfortable temperature under all but the most extreme weather conditions. Provided, however, that in the interest of energy conservation, and in keeping with the temperature standards established for state-owned buildings, the temperature should be maintained, wherever practicable, no higher than 65 degrees Fahrenheit in the coldest occupied area within the leased premises.
- 10.4. Cooling: LESSOR shall provide air-conditioning capable of cooling the leased premises to a temperature of 15 degrees Fahrenheit cooler than the prevailing outside air temperature. In the interest of energy conservation, and in keeping with the temperature standards established for state-owned buildings, the temperature should be maintained, wherever practicable, no lower than 78 degrees Fahrenheit in the warmest occupied area within the leased premises.
- 10.5. In the event any kind of energy conservation measures are enacted by State or Federal authority, it is hereby agreed that the LESSOR shall reduce the quantity of utilities and services as may be specifically required by such governmental orders or regulations. Utilities, within the meaning of this article, include heat, cooling, electricity, water and all the sources of energy required to provide said services.
- 10.6. LESSOR shall provide the premises with overhead lighting to provide sufficient foot candle power at desk level.
- 10.7. LESSOR shall provide, at its own expense, sufficient light, heat, and maintenance to the rental area and public access to the premises, including stairways, elevators, lobbies and hallways, so that such areas shall be safe and reasonably comfortable.
- 10.8. LESSOR shall keep the public sidewalks adjacent to the building and any sidewalks or stairways leading from the public sidewalks to the building free from snow, ice and debris, including the parking lot.
- 10.9. LESSOR shall provide the premises with a means or system of waste or trash disposal.

11. DUTIES OF THE LESSEE:

- 11.1. LESSEE shall allow access to the premises by LESSOR or its authorized representatives at any reasonable time during the life of this Lease Agreement for any purpose within the scope of this Lease Agreement.
- 11.2. LESSEE shall not use the premises at any time for any purpose forbidden by law.
- 11.3. LESSEE shall not assign, sublet, or otherwise transfer LESSEE'S interest in this Lease Agreement without the prior written consent of LESSOR.

12. PROPERTY DAMAGE, INSURANCE, AND LIABILITY: It shall be the duty of LESSOR and LESSEE to maintain insurance or self-insurance on their own property, both real and personal. LESSOR and LESSEE agree that each party will be responsible for its own acts and the results thereof to the extent authorized by law and shall not be responsible for the acts of any others and the results thereof. LESSEE'S liability shall be governed by the provisions of the Minnesota Tort Claims Act, Minnesota Statutes, Section 3.736, and other applicable law. LESSOR'S liability shall be governed by the provisions of Minnesota Statutes, Section 466.04, and other applicable law. In the event of any claims or actions filed against either party, nothing in this Lease Agreement shall be construed to allow a claimant to obtain separate judgments or separate liability caps from the individual Parties.

13. MAINTENANCE AND REPAIRS:

- 13.1. It shall be the duty of the LESSOR to maintain at its own expense, in working condition, all appurtenances within the scope of this Lease Agreement, including the maintenance of proper plumbing, wiring, heating (and, where applicable, cooling) devices and ductwork.
- 13.2. LESSOR shall, at its own expense, make such necessary repairs, so as to continue to provide all such service appurtenances as are required by this Lease Agreement, provided, however, that LESSOR shall not be responsible for repairs upon implements or articles which are the personal property of LESSEE, nor shall the LESSOR bear the expense of repairs to the leased premises necessitated by damage caused by LESSEE beyond normal wear and tear.
- 14. JANITORIAL SERVICE: LESSOR shall provide janitorial services and supplies for cleaning of the leased space, trash removal, and replacement of fluorescent bulbs, starters and ballasts, as needed.
- 15. UTILITIES: LESSOR shall bear the cost of heat, electricity, air conditioning, sewer and water services.
- 16. Pursuant to Minnesota Statutes 1988, Section 16B.24, Subdivision 6, this Lease Agreement is subject to cancellation upon thirty (30) days' written notice by the State for any reason except rental of other land or premises for the same use.
- 17. The LESSOR agrees that in exercising its management responsibilities of the leased premises, including in particular the maintenance, repair, alterations and construction relating thereto, it shall fully comply with all applicable laws, rules, ordinances and regulations as issued by any political subdivision having jurisdiction and authority in connection with said property.

- 18. Pursuant to Minnesota Statute Section 16C.05, subd. 5, the books, records, documents and accounting procedures and practices of LESSOR relevant to this Lease Agreement shall be subject to examination by the State and/or Legislative Auditor, during normal business hours and after reasonable notice to LESSOR.
- 19. LESSEE agrees to observe reasonable precautions to prevent waste of heat, electricity, water, air-conditioning or any other utility or service, whether such is furnished by LESSOR, or obtained and paid for by LESSEE.
- 20. The LESSOR agrees to provide and maintain the leased premises with accessibility and facilities meeting code requirement for handicapped persons on the main and lower levels whenever possible.

21. EXPANSION SPACE:

In the event LESSEE leases any additional space elsewhere in the building, the rent for said space shall be calculated at the rate per square foot per year that is in effect under this Lease Agreement at that time as provided in Section 1 of this Lease Agreement. LESSOR shall provide improvements to the expansion space comparable to the improvements provided to the space leased under this Lease Agreement. An Amendment shall be executed setting forth the amount of such expansion space, the effective date of LESSEE'S right of occupancy, and the amount of additional rent that shall be due and payable to LESSOR.

22. LESSEE INSTALLED PROPERTY:

Any equipment, trade fixtures or furniture installed by the LESSEE including but not limited to moveable partitions, shelving units, projection screens and audio-video equipment attached to the leased premises by the LESSEE, shall remain the property of the LESSEE. LESSEE shall have the right to remove the above equipment or fixtures at the expiration or termination of this Lease Agreement or any extension thereof, even though said equipment or fixtures are attached to the leased premises, provided that floor and wall surfaces are reasonably restored.

23. TELECOMMUNICATIONS:

LESSOR shall provide, at its expense, the following telecommunications requirements:

- a. Establish and identify the location of the minimum point of presence (MPOP) for dial tone service provided by the telephone company;
- b. Provide a telecommunications equipment area on the floor(s) of which the leased premises is a part, including a minimum of one (1) separately fused dedication quad electric outlet;
- c. Provide all required cable from the MPOP to the telecommunications panel on the floor of which the leased premises is a part for present and future requirements;
- d. Provide access for wiring from the telecommunications equipment area on each floor to each workstation location on the floor; and
- e. Identify the access to the building grounding electrode.

24. LIAISON/NOTIFICATION:

24.1. To assist the parties in the day-to-day performance of this Lease Agreement and to ensure compliance with the specifications and provide ongoing consultation, a liaison shall be designated by LESSEE and by LESSOR. The parties shall inform the other, in writing, of any change in the designated liaison. At the time of execution of this Lease Agreement, the following persons are the designated liaisons:

In addition, notification to the County regarding breach or termination shall be provided to the office of the County Attorney, 1560 Highway 55, Hastings, Minnesota 55033.

25. USABLE SPACE MEASUREMENTS:

It is understood by LESSOR and LESSEE that the rent schedule is based upon the number of usable square feet of space occupied by LESSEE. Usable square feet for purposes of the Lease Agreement and calculating rent shall be computed by measuring the inside finished surface of exterior walls to the inside finished surface of building corridor and other permanent walls or to the center of walls separating the leased premises from other tenant space. If more than 50% of an exterior wall is glass, the dimension is taken from the glass line. Vertical shafts, elevators, stairwells, dock areas, mechanical rooms, and utility and janitor rooms are excluded. Restrooms, corridors, lobbies and receiving areas which are accessible to the general public or used in common with other tenants are also excluded. No deductions are made for columns, pilasters or other projections to the building if each is less than four (4) square feet.

26. INTEGRATION:

This Lease Agreement is the final expression of the agreement of the parties and the complete and exclusive statement of the terms agreed upon, and shall supersede all prior negotiations, understandings, or agreements. There are no representations, warranties, or stipulations, either oral or written, not contained in this Lease Agreement.
