TITLE

Authorization To Add 12 Full-Time Equivalent Positions Required To Staff Jail Integrative Health Unit

PURPOSE/ACTION REQUESTED

Authorize the Sheriff to add 12 Full-Time Equivalent (FTE) positions (11.0 FTE grade 105 positions, 1.0 FTE Correctional Deputy grade 106 position), to begin the process of hiring required staffing for the jail's Integrative Health Unit that is anticipated to open in the first quarter of 2025.

SUMMARY

The Sheriff is mandated to provide care of those in custody per Minnesota Administrative Rules 2911.5800, and Minn. Stat. § 641.15. Approximately 25 percent of the Sheriff's jail inmate population includes those with serious health needs that should be addressed while they are in custody. The greatest challenge for the Sheriff has been providing an appropriate space dedicated to this care. During a 2020 needs assessment of the Sheriff's Office Jail, Dakota County's Office of Planning and Analysis completed a project scope summary. The findings recommended the addition of a dedicated jail housing unit to address the medical and mental health needs of inmates. This additional unit, the Integrative Health Unit, consists of a 28-bed self-contained unit that provides specialized care and support to those inmates with physical health limitations, substance abuse disorders, or mental health needs. This specialized and intentional support increases the likelihood of success while in custody and after release, having an impact on individuals, families, and the community.

The Dakota County Board of Commissioners approved the construction of the Integrative Health Unit which was funded through 2021 and 2022 Buildings and CIP dollars, and in 2023 utilizing county fund balance. In the fall of 2022, the Integrative Health Unit schematic design was approved, and groundbreaking began in the fall of 2023. The project is anticipated to be completed and ready for occupancy in the first quarter of 2025.

The Minnesota Department of Corrections and the Dakota County Office of Planning and Analysis conducted a staffing need assessment for the new unit and determined that it would require an additional 12 Correctional Deputies. The annual cost of the addition 12 FTE Correctional Deputies was estimated to be 1.2 million dollars.

The Sheriff reviewed the staffing recommendation and identified an alternative and less costly approach to staff the new unit. That includes the reclassification and creation of new positions at a lower job classification level to perform current, selective Correctional Deputy duties. 11 of the Sheriff's requested 12 additional FTE positions will perform administrative and non-inmate contact

duties that are currently tasked to Correctional Deputies. These tasks include operating the jail's control room and fingerprinting in the courts. This organizational change to backfill 11 Correctional Deputies currently performing those duties will allow those Deputies to be assigned to the new Integrative Health Unit. This revised staffing model will save Dakota County roughly \$100,000 per year compared to hiring 12 FTE Correctional Deputies.

In addition to the above request of the 11.0 FTE grade 105 positions to backfill Correctional Deputy control room and fingerprinting duties, the Sheriff requests an additional 1.0 FTE Correctional Deputy grade 106 to fill the requirement of 12 new Correctional Deputies for the new Integrative Health Unit.

The approval of these anticipated and required 12 positions in 2024 will allow staff to be hired and trained ahead of the opening of the Integrative Health Unit. The hiring and training of new jail staff can take up to six months. Upon the County Board of Commissioner's approval, the Sheriff will begin the hiring process with the intention to hire added staff in the second or third quarter of 2024.

RECOMMENDATION

Authorize the addition of 12 Full-Time Equivalent (FTE) positions (11.0 FTE grade 105 positions, 1.0 FTE Correctional Deputy grade 106 position), to begin the process of hiring required staffing for the jail's Integrative Health Unit that is anticipated to open in the first quarter of 2025.

EXPLANATION OF FISCAL/FTE IMPACTS

Dakota County Finance identified projected 2024 Sheriff's salary savings to cover the 2024 salaries and benefits of the added positions. The Sheriff could also utilize the State's recently awarded Public Safety Fund balance to offset qualifying budget expenditures if needed to ensure a 2024 zero net cost to the County to fund the additional 12.0 FTE positions. Ongoing funding for the positions will be included in the 2025 County Manager's Recommended Budget.

WHEREAS, the Sheriff is mandated to provide care of those in custody per Minnesota Administrative Rules 2911.5800, and Minn. Stat. § 641.15; and

WHEREAS, the Sheriff identified an alternative and less costly approach to staff the new unit utilizing 11.0 FTE, grade 105 to backfill existing Correctional Deputy administrative and non-inmate contact duties: and

WHEREAS, the Sheriff is requesting 12.0 FTE consisting of 11.0 FTE in grade105 and 1.0 FTE Correctional Deputy in grade 106 to fulfill the requirement and begin hiring and training staff in the anticipation of the Integrative Health Unit; and

WHEREAS, the costs associated with the new positions in 2024 will be covered by the Sheriff's budget savings at a zero net cost to the county in 2024.

NOW, THEREFORE, BE IT RESOLVED, That the Dakota County Sheriff is hereby authorized to add 12.0 Full-Time Equivalent (FTE) positions, consisting of 11.0 FTE in grade 105, and 1.0 FTE in grade 106, to begin the process of staffing the jail's Integrative Health Unit that is anticipated to open in the first quarter of 2025, with the cost associated with the new positions in 2024 to be covered by the Sheriff's budget savings.
