WHEREAS, Dakota County obtained the enactment of special legislation authorizing the Dakota County Board of Commissioners to adopt a modified county manager form of government, in Minnesota Laws, 2014, Chapter 167; and

WHEREAS, under the County Manager form of government the administrative and executive powers of the County Board are assigned by law to the County Manager; and

WHEREAS, the recent County manager retired in May 2024 and the County has conducted an extensive search and interview process to select a successor County Manager; and

WHEREAS, the search process has identified qualified candidates for the position of Dakota County Manager; and

WHEREAS, the County Board greatly appreciates the participation of all candidates in the application and interview process.

NOW, THEREFORE, BE IT RESOLVED, That the Dakota County Board of Commissioners hereby directs staff to negotiate terms with Heidi Welsch for the County Manger position; and

BE IT FURTHER RESOLVED, That the Dakota County Board of Commissioners hereby schedules a special County Board meeting on July 23, 2024 at 11:00 a.m., Conference Room 3A, Administration Center, Hastings for the purpose of considering approval of an employment contract and appointment of the next County Manager.
