School Zone Speed Limit Definitions and Authority





Speed Limit

 Set by Commissioner of Transportation based upon engineering study per MN Statue 169.14 Subd. 5



School Zone – School Area




School Zone Speed Limit

- Part time when children are present
- Local authority upon engineering and traffic investigation prescribed by Commissioner of Transportation per MN Statue 169.14 Subd. 5a
- Minnesota Manual on Uniform Traffic Control Devices 169.06 contains prescribed process

School Zone Speed Limit Prescribed Process



- School route plan
 - Completed for each school area
- School zone hazard evaluation
 - 9 factors for consideration
 - School zone speed limit considered after other factors are addressed
- Recommend corrective action
- Education / Enforcement



School Zone Speed Limit Safety Considerations



- Maximum 30 mph reduction from established speed
- Minimum 15 mph posted speed
- Consideration for effectiveness
 - Research, focus reduction to the pedestrian crossing activity
 - Compliance for consistency

Reasons for Re-evaluation



- Background of School Speed Limits
 - CSAH 28, 80th Street 20 mph speed established
 1991
 - CSAH 30, Diffley 30 mph speed established 2019
- Update based on new roadway projects
 - CSAH 28 (80th St.)
 - CR 30 (Diffley Road)
- School Speed Zone Evaluation Following the prescribed Process
- Recommendations

Evaluation – CSAH 28, 80th Street



- Route Plan -- Focuses on Crossing CSAH 28 at Boyd Avenue
 - Project Work / Crossing Enhancements
 - School Crossing Guards
 - Education

- Collected Count Data and Speed Data
- Meeting With City / School Officials

Recommendation – CSAH 28, 80th Street





- Establish school speed zone with greater compliance 25 mph
 - Focused on the crossing at Boyd Road
 - Speed Sign with new flashing beacons

Evaluation – CSAH 30, Diffley Road



- Route Plan -- Focuses on Crossing at the two Roundabouts
 - Reconstruction of Diffley Road
 - Safe Route to School Work
 - School Crossing Guards
 - Education
 - Enforcement
- Collected Count Data and Speed Data
- Meeting With City / School Officials

Recommendation – CSAH 30, Diffley





- Retain current 30 mph school speed zone through the Diffley Road corridor
- Retain signing eastbound, add dynamic sign westbound
