- Budget workshop on outlook and assumptions for 2023 budget planning (June 21)
- Budget and levy planning workshop (August 23)
- Proposed Maximum levy adoption (September 20)
 \$147,361,306 (1.9% change) for County
- County Board budget hearings (November 14-17)
- Budget and levy (TNT) hearing (November 29)
- 2023 budget adoption (December 13)

Budget environment for 2023



- Higher cost growth on existing operations (current level)
- Account for committed and unavoidable cost increases
- Increased service demands and provider capacity issues
- Tight labor market
- State and federal fiscal support is uncertain



2023 Operating vs. Capital Service Budget








2023 Recommended Operating Budget by Division

Major Elements of 2023 Budget



- Operating budget increases 5.5%
- Adds internal capacity in human services to address
 provider shortages
- Limited growth in other priority areas
- Capital budget plan for 2023-27 totals \$746 million -financed from levy, savings, non-County funds...and no debt.
- Recommended County tax levy increased 1.9% for 2023


Proposed 2023– County Tax Rate Calculation

2023 tax rate will remain lowest of Metro counties






**In St Paul and Minneapolis there is a different level of services and therefore a higher county rate. All remaining cities in both counties pay the suburban rate and tax.
