SUMMARY

Pursuant to Minn. Stat. § 340A.414, the Commissioner of Public Safety can issue an on-business-premises intoxicating liquor Consumption and Display Permit only after approval by the governing body of the county in which the establishment is located. The County Attorney and County Sheriff have reviewed the application and find that the applicant is eligible to be permitted.
